### MOTION TO APPROVE PROPOSED <u>SALE TO CENTURION SERVICE GROUP, LLC</u> (<u>Scottsdale Assets</u>)

The Assignee seeks to take the action described herein. Objections must be filed and served within twenty-one (21) days from the service of this Motion. In the event an objection is timely filed and served, the Court will hold a hearing on October 2, 2019 at 2:00 p.m. to consider any timely filed objections, and to consider the Assignee's Motion to Approve Proposed Sale to Centurion Service Group, LLC before the Honorable Judge Steven Scott Stephens, Hearing Room 512, 800 East Twiggs Street, Tampa, Florida 33602.

If no objection is timely filed and served, then all creditors and parties in interest have consented to the relief sought in this Motion and the Assignee shall submit a proposed order to the Court. The deadline to object is twenty-one (21) days from service of this Motion.

Soneet Kapila, as assignee ("Assignee") for Laser Spine Institute, LLC, pursuant to Fla. Stat. §§ 727.108 and 727.109, hereby provides notice to all parties in interest that he intends to sell certain assets of Laser Spine Institute, LLC and moves the Court to approve this sale and resolve any objections to the relief and notice sought herein (the "Motion"), and states:

#### **Background**

- 1. On March 14, 2019, Laser Spine Institute, LLC ("LSI") executed and delivered an assignment for the benefit of creditors to the Assignee. The Assignee filed a Petition with the Court on March 14, 2019, commencing an assignment for the benefit of creditors proceeding pursuant to Section 727 of the Florida Statutes (the "LSI Assignment Case").
- 2. Simultaneous with the filing of the LSI Assignment Case, the Assignee filed fifteen other Petitions commencing assignment for the benefit of creditors proceedings for 15 affiliates of LSI (the "Affiliated Assignment Cases," and together with the LSI Assignment Case, the "Assignment Cases"): LSI Management Company, LLC; Laser Spine Institute Consulting, LLC; CLM Aviation, LLC; Medical Care Management Services, LLC; LSI HoldCo, LLC; Laser Spine Surgical Center, LLC; Laser Spine Surgery Center of Arizona, LLC; Laser Spine Surgery Center of Cincinnati, LLC; Laser Spine Surgery Center of St. Louis, LLC; Laser Spine Surgery Center of Pennsylvania, LLC; Laser Spine Surgery Center of Oklahoma, LLC; Laser Spine Surgery Center

of Warwick, LLC; Laser Spine Surgery Center of Cleveland, LLC; Total Spine Care, LLC; and Spine DME Solutions, LLC.

### **Relief Requested**

- 3. Through the Motion, the Assignee hereby seeks authority to sell certain equipment, furniture, fixtures, supplies, and inventory located at 8888 E. Raintree Drive, Scottsdale, Arizona 85260 (the "Assets"), as described on the Bill of Sale and Assignment (the "Bill of Sale"), to a third party purchaser, Centurion Service Group, LLC (the "Buyer"), for a net cash price of \$390,000.00 (the "Sale Price"), and to remit the Sale Price to the Assignee. A true and correct copy of the Bill of Sale is attached hereto and incorporated herein as Exhibit A. The Assignee previously engaged the Buyer to perform appraisals, to perform an inventory and, if necessary, to remove from the various leased locations the furniture, fixtures, and equipment owned by the Assignors and conduct an auction if necessary. It is further agreed that the Buyer will waive the amounts due for performing the inventory of the Assets and any commissions related to the Assets. All other inventory fees and appraisal fees for other locations will remain in place, due and owing, subject to Court approval. In addition, the Buyer is responsible for (and shall pay) any costs resulting from the removal of the Assets from the leased premises in Scottsdale, Arizona.
- 4. The Assets are being sold "As Is", "Where Is", without any guarantees or warranties regarding their merchantability or fitness for any particular purpose, and all such guarantees and warranties are hereby expressly disclaimed.
- 5. The Assets shall be sold free and clear of any liens, claims and encumbrances, with any such liens to attach to the proceeds of the sale. The Buyer has no affiliation with the Assignee. The parties have acted in good faith and the terms of the purchase of the Assets were negotiated in an arms' length transaction.

- 6. Section 727.108(1) of the Florida Statutes, which delineates the "Duties of Assignee," provides that the Assignee shall "Collect and reduce to money the assets of the estate, whether by suit in any court of competent jurisdiction or by public or private sale . . . ." Fla. Stat. § 727.108 (2016).
- 7. The Assignee has determined that the sale of the Assets as contemplated by this Motion is in the best interest of the estate because the Assignee has determined that the purchase price offered by the Buyer is the highest and best offer for the Assets.
- 8. Texas Capital Bank, National Association, in its capacity as Administrative Agent to the lender group, asserts a lien on the Assets and consents to the sale, provided that (a) liens shall attach to the sale proceeds as their interests may appear and (b) nothing in this Motion or the Order granting this Motion shall be deemed or construed to modify LSI's obligations under the Credit Agreement (or any related documents or agreements), dated as of July 2, 2015, by and between Laser Spine Institute, LLC, LSI Management Company, LLC, Laser Spine Institute Consulting, LLC, and Medical Care Management Services, LLC, as Borrowers, and Texas Capital Bank, National Association, as Administrative Agent. Within three (3) business days of the closing of the sale of the Assets, the Assignee shall remit the Sale Price to the Agent for application in accordance with the Credit Agreement.
- 9. For all the reasons set forth above, the sale of the Assets to the Buyer as set forth herein is reasonable under the circumstances, is within the Assignee's best business judgment, and is in the best interests of the estate.

WHEREFORE, the Assignee respectfully requests the entry of an order granting the Motion and granting such other and further relief as is just.

MOTION TO APPROVE PROPOSED SALE TO CENTURION SERVICE GROUP, LLC (Scottsdale Assets)

#### **BILL OF SALE AND ASSIGNMENT**

This **BILL OF SALE AND ASSIGNMENT** ("Bill of Sale") is made and entered into as of September 5, 2019, (the "Effective Date") by and between Centurion Service Group, LLC, an Illinois limited liability corporation, ("Buyer") and Soneet Kapila, as assignee of Laser Spine Institute, LLC, a Florida limited liability company ("Seller"). The Buyer and Seller may be referred to each individually as a "Party" and collectively as the "Parties."

WHEREAS, on March 14, 2019, Laser Spine Institute, LLC executed and delivered an assignment for the benefit of creditors to Soneet Kapila, as assignee. Soneet Kapila, as assignee, filed a Petition in the Thirteenth Judicial Circuit Court of Hillsborough County, Florida (the "Assignment Court") on March 14, 2019, commencing an assignment for the benefit of creditors proceeding pursuant to Section 727 of the Florida Statutes.

WHEREAS, subject to approval by the Assignment Court, Seller desires to sell, convey, transfer, assign, and deliver, and Buyer desires to purchase and acquire, all of the Seller's rights, title, and interest in and to the asset(s) set forth on Schedule A of this Bill of Sale (the "Assets").

**NOW, THEREFORE**, in consideration of the premises and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

- 1. Assignment. Seller hereby irrevocably and unconditionally sells, conveys, transfers, assigns, and delivers to Buyer, its successors and assigns, all of Seller's right, title, and interest in and to the Assets, to have and to hold the same and each other and all thereof unto Buyer, its successors and assigns, to its own use and benefit forever.
- 2. Purchase Price. As consideration for the sale and purchase of Assets, within five calendar days of the entry of an order approving this Bill of Sale by the Assignment Court and an order approving that certain Settlement Agreement between the Assignee and Raintree III/IV Property Owner, LLC by the Assignment Court, Buyer shall pay Seller in immediately available funds an amount equal to \$390,000.00 net ("Purchase Price"). The Purchase Price does not include sales tax, excise tax or other taxes relating to the sale of the Assets identified herein and any and all of which shall be for Buyer's account. Payment of the Purchase Price shall be made via cashier's check, wire, or electronic transfer of funds. Buyer shall be responsible for (and shall pay) all costs associated with the removal of the Assets from the premises located at 8888 E. Raintree Drive, Scottsdale, Arizona 85260. It is further agreed that the Buyer will waive the amounts due for performing the inventory of the Assets and commissions related to the Assets. All other inventory fees and appraisal fees for other locations will remain in place, due and owing.
- **3. Representations.** Seller hereby represents and warrants to Buyer that to the best of his information and belief:
  - A. Seller has good and marketable title to the Assets.

- B. Seller has full legal right, title, and (subject to approval of the Assignment Court) authority to sell, assign, and transfer to Buyer valid title to the Assets free and clear of all liens, encumbrances and charges.
- 4. Disclaimer of Warranties. The Assets are sold and conveyed by Seller and purchased and accepted by Buyer in their condition on the Effective Date "AS IS," "WHERE IS," and "WITH ALL FAULTS" WITH NO WARRANTIES, INCLUDING, WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, with respect to the condition of the Assets, ANY AND ALL OF WHICH WARRANTIES (BOTH EXPRESS AND IMPLIED) SELLER HEREBY DISCLAIMS.
