## FORMER LSI EMPLOYEES' AND WARN ACT CLASS MEMBERS' MOTION TO ATTEND MEDIATION IN "D & O LITIGATION"

1. Class Representatives Deanna Ali ("Ali") and Heather Embry ("Embry")(collectively "the WARN Class Representatives"), on behalf of a certified class ("the

WARN Act Class Members"), hereby move for an order allowing them to attend an upcoming mediation in the D & O litigation.

- 2. Ali and Embry represent a national group of approximately 500 former LSI employees whose rights under the WARN Act were violated because they received no advance notice of Defendants' ("LSI") March 1, 2019 mass layoff.
- 3. The WARN Act Class Representatives filed a class action lawsuit in the Middle District of Florida against several of the LSI entities on March 4, 2019 ("the federal case"). The WARN Act Class Members seek relief against LSI for statutory WARN Act remedies consisting of sixty days' pay and loss of benefits.
- 4. The federal case was stayed on March 19, 2019, due to this Notice of Assignment for the Benefit of Creditors ("the ABC case") filed by LSI.
- 5. On June 13, 2019, the federal court re-opened the federal case so the WARN Class Representatives -- with LSI's consent -- could move for class certification of the WARN Act Class Members' claims.
- 6. The federal court certified the class on July 8, 2019, and approved notice on July 26, 2019.
- 7. In the interim, the WARN Act Class Representatives timely filed a class proof of claim in this case on behalf of the WARN Act Class Members.
- 8. The Class Representatives have been diligently pursuing this matter, and also working with the trustee to try to resolve this case. However, the WARN Act Class Members have not been offered, much less obtained, any monetary relief whatsoever.

- 9. Counsel for the WARN Act Class Members recently learned that a mediation is scheduled in May of 2020 for the parallel D & O litigation. That litigation involves claims made against certain individuals and LSI officers.
- 10. Because the D & O litigation contains allegations made against certain individuals for failure to comply with the WARN Act, counsel for the WARN Act Class Members should be permitted to attend the D & O mediation to ensure the rights of the 500 class members are both advanced, and also protected.
- 11. LSI opposes allowing counsel for the WARN Act Class Members to attend mediation in the D & O litigation. For reasons that are unclear the WARN Act Class Representatives, LSI takes the position that "consistent with the position taken by the Assignee with other parties in in interest in the assignment cases who have asked to attend the mediation, that no other parties in interest, including the WARN Act claimants, will be allowed to attend mediation."
- 12. However, allowing counsel for the WARN Act Class Members to attend mediation will not prejudice any party to the D & O litigation.
- 13. Rather, allowing counsel for the WARN Act Class Members to attend mediation in the D & O litigation will serve to protect the interests of the nearly 500 WARN Act class members, and help to ensure their claims are not negatively impacted by its outcome.

**WHEREFORE**, the WARN Act Class Representatives respectfully move this Honorable Court for an order permitting their counsel to attend mediation in the D & O litigation. A proposed order is attached hereto as Exhibit A.
