**ORDER SUSTAINING OMNIBUS OBJECTION TO
RESOLVED MEDICAL MALPRACTICE CLAIMS**

THESE CASES came on for consideration upon the Omnibus Objection (the “**Objection**”) to Resolved Medical Malpractice Claims (the “**Resolved Medical Malpractice Claims**”). The

Objection seeks to disallow the Resolved Medical Malpractice Claims. The Objection was filed on January 5, 2024, and was served by negative notice. An Amended Certificate of Service was filed on January 17, 2024. No responses to the Omnibus Objection were filed. The Court finds that under the circumstances of this case, due and sufficient notice of the Objection was provided to parties, and that such notice was adequate and appropriate. Therefore, any requests for other and further notice shall be and hereby are dispensed with and waived, and no other or further notice is necessary. The Court, having considered the Omnibus Objection, and being fully advised of the record, finds that the Omnibus Objection should be sustained. Accordingly, it is

ORDERED:

1. The Omnibus Objection is sustained.
2. The Resolved Medical Malpractice Claims listed on **Exhibit A** hereto are disallowed.
