ORDER SUSTAINING OMNIBUS OBJECTION TO FORMER EMPLOYEE CLAIMS

necessary. The Court, having considered the Objection, and being fully advised of the record,

finds that the Objection should be sustained. Accordingly, it is

ORDERED:

1. The Objection is sustained.

2. The Former Employee Claims listed on **Exhibit A** hereto are disallowed.

3. The claim of Karen Sandifer shall not be disallowed at this time. This order is

without prejudice to the Assignee seeking further relief as to the claim filed by Karen Sandifer.
